Federal Government Employees Housing Authority (FGEHA), Karachi Office invites sealed proposals from Engineering Consultant firms for "DESIGNING, PROCUREMENT AND DETAILED CONSTRUCTION SUPERVISION OF INFRASTRUCTURE DEVELOPMENT WORKS OF SECTOR 24-B, SECTOR 25-B, SECTOR 18-C, SECTOR 19-C AND SECTOR 4-C AT KDA SCHEME-33, GULZAR-E-HIJRI, KARACHI". The firm must have adequate experience of planning, designing and construction supervision of infrastructure development works.

The firm must be eligible to handle the works and should have valid PEC registration with fields of specialization in relevant category and code. Proposals are to be submitted at the address mentioned below by 27 -03-2020 at 1100 Hrs and will be opened on the same day at 11:30 AM in the presence of authorized representative of consultants who choose to attend.

All the applicable Federal/Provincial taxes must be considered while preparing the Financial Proposal and are required to be built in the quoted rates and not be mentioned separately. The bidders providing fake, forged, unsubstantiated and false information shall be liable to legal actions i.e. disqualification and blacklisting.
