Federal Government Employees Housing Authority invites sealed bids (Technical and Financial bids) under "Single Stage Two Envelop" procedure from firms registered with Pakistan Engineering Council having valid Registration Certificate in Category C-4 or above, who can prove their eligibility and qualification as mentioned in the Bidding Documents for the following project:-

"Development of Playgrounds in Sector G-13, Islamabad."

- 1. **"Single Stage-Two Envelope Procedure"** of Open Competitive Bidding shall be adopted in accordance with Clause 36(b) of PPRA Rules, 2004.
- 2. Bidding Documents can be purchased from the office of the undersigned after publication of this notice up to 28th December, 2020 during office hours against a non-refundable fee of Rs. 2000/- in the shape of cash.

All bids must be delivered to Deputy Director (Maintenance), Federal Government Employees Housing Authority (FGEHA), Maintenance Directorate, Street # 13, Bazar # 5, Sector G-13/3, Islamabad at or before 1130 hours, on 29th December, 2020. Technical Bids will be opened at 1200 hours on the same day, in the presence of bidder's representatives who choose to attend at the same address. Sealed Financial Bids shall be held in the custody of the Employer.
- 4. Those firms who have been Technically Qualified shall be informed in writing regarding date and time of opening of Financial Bid.
- 5. All bids must be accompanied by a Bid Security amounting to (2) % of the Bid amount in the shape of a CDR issued by a Scheduled Bank of Pakistan in favour of Federal Government Employees Housing Authority (FGEHA), Islamabad.
- 6. A Pre-bid meeting will be held on 23rd December, 2020 at 11:00 Hours, at Federal Government Employees Housing Authority (FGEHA), Maintenance Directorate, Street # 13, Bazar # 5, Sector G-13/3, Islamabad.
- 7. Tenders through fax/post/Telegraph/E-mail shall not be entertained.
- 8. Under Rule 33(1) of PPRA Rules, 2004, FGEHA reserves the right to accept or reject all bids.
- 9. The submission of Tender by the Contractor implies that he is fully conversant with the site of work, scope of work and conditions laid down in the Tender Documents.
- 10. Conditional tenders will not be acceptable.
- 11. Tenders will be issued to authorised representatives of Original Contractors.
