Terms and conditions

- Interested firms/Contractors may purchase the tender documents upon written application on original letter pad from the office of the undersigned up to **26-02-2021** during office hours against cash payment of specified fee.
- Tender must be accompanied with call deposit 2 % of the price of bid amount from any schedule bank of Pakistan in favor of Federal Government Employees Housing Authority, Islamabad.
- No tender will be entertained without call deposit of required amount.
- The submission of tender by the contractor implies that he is fully conversant with the site of work, scope of work, terms & conditions laid down in the tender documents.
- The tender documents may be submitted latest by **02-03-2021 at 11-00 AM** & will be opened on the same date at 11-30 AM in the presence of bidders or their representative.
- Conditional tender will not be acceptable.
- The contractor will have to produce original CNIC, Income Tax registration (NTN), Power of attorney, Partnership deed original, Non Judicial stamp paper worth Rs 10/- along with attested photocopies.
- PEC Certificate 2019 and professional tax certificate ,FBR income tax clearance certificate in original will be seen before issuance of Tender .**
- In case the total bid mount is less than 10 % below the NIT amount, the bidder shall submit Call deposit as performance security equal to the difference between NIT amount and total quoted amount less 10 % of NIT amount .That is required Performance security = NIT Amount – Total bid amount – 10 % of NIT amount . This call deposit shall be in addition to the earnest money for the work and shall be deposited at the time of submission of bids .Bids not carrying the performance security shall be rejected .The performance security of successful bidder shall be released after completion of project .
