TENDER NOTICE FOR THE SUPPLY OF WATER THROUGH PRIVATE TANKERS IN SECTOR G-13 ISLAMABAD.

Sealed tenders are invited from the Suppliers/Contractors/Firms and services providers on "<u>per tanker rate basis" (for 12 months)</u> holding NTN/GST certificate and having experience in field of water supply for the supply of drinking water through Private tankers in Sector G-13 Islamabad. On the following terms and conditions.

Terms and conditions

- Interested firms/Contractors may purchase the tender documents upon written application from the office of the undersigned up to <u>05-07-2021</u> during office hours against cash payment of Rs.1500.
- 2. Tender must be accompanied with call deposit **02** %of quoted amount for 12 months supply will be deposited in shape of bank draft/pay order in favor of Federal Govt. Employees Housing Authority, Islamabad for the above-mentioned works separately.
- 3. No tender will be entertained without call deposit of quoted amount for 12 Months.
- 4. Price quoted shall be per tanker basis and shall remain valid for a period of 12 months. Quoted price shall be inclusive of all applicable taxes.
- 5. The estimated requirements of water tankers range minimum 100 per day.
- 6. The supplier will be bound to supply water to all complaints on the same day to avert the possibility of any back log.
- 7. The water tanker should be of standard size equal 1400 Glns in shape of small tanker(For One House) or 2800 Glns in shape of large tanker(For two Houses)factor fixed with tractor with dual operating system to cover the underground and overhead tanks up to 30' feet height).
- 8. Federal Governments Employees Housing Authority reserve the right to accept or reject any or all the tenders without any reason under rule 33 (1) of PPRA 2004.
- 9. In view of public health care, it will be better if the supplier holds the water supply license of the CDA and owns his own tube well or water reservoir and its water has been got tested from Govt. laboratory of any other relevant organization and declared to be fit for human consumption.
- 10. The tender documents may be submitted latest by **06-07-2021** at 11-00 AM& will be opened on the same date at 11-30 AM in the presence of bidders or their representative.
- 11. Conditional tender will not be acceptable.
- 12. Initially the contract period duration is 06 months however can be extended for another period of 06 months subject to the satisfactory performance.
- 13. The contractor will have to produce NIC, Income Tax registration (NTN), in original along with attested photocopies with application for purchase of tender documents.
