2. Bidders are required to submit the following documents with their offer otherwise their offer will not be considered.

  - II. Copy of G.S.T Certificate
  - III. Copy of Certificate from Pakistan Standard & Quality Authority (PQSA).
  - IV. List of Clients along with copies of work order/agreement with their clients organizations.
3. Interested bidders may send their Offers / Quotation in sealed envelopes duly marked.
4. All Firms must be submit Bid security of Rs. 50,000/- (re-fundable) in shape of bank Draft / Pay order in favor of FGEHA, Islamabad.
5. Bid security of Qualified Firms only will be returned on successful completion of the contract period. Non-compliance / early termination of contract / concealment of facts / any litigation and security breach may result in confiscation of bid security, legal action and blacklisting of firm.
6. Tender document / required services and detail terms & conditions can be obtained any time from CS section of this office at the cost of Rs. 1000/- (non-refundable).
7. Physical Inspection of water plant may be carried out by tender committee before placing of contract.

8. Agreement with successful bidders will be made for one year.
9. That the contract must be cancelled at any time giving one month notice if the supplier provide inferior quality supply/upon unsatisfactory performance.
10. Payment will be made on Monthly basis as mutually agreed, on submission of bill along with receipts verified by caretaker Authority and firm's representative both.
11. An affidavit on stamp paper that the firm is never blacklisted maybe accompanied with the sealed tender.
12. The firm must be provide water dispenser when and ever required by FGEHA and also repairing and maintance work by firm.
13. FGEHA reserves the right to accept or reject any or all bids with assigning cogent reason.
