Federal Government Employees Housing Authority (FGEHA), invites sealed bids from reputed construction firms for **“RENOVATION OF APARTMENTS FOR FEDERAL GOVERNMENT EMPLOYEES AT COMMERCIAL PLOTS FL & SB, SECTOR 24-B, FGEHA HOUSING SCHEME PHASE-I, KDA SCHEME-33, GULZAR-E-HIJRI, KARACHI (PACKAGE-II)”** having adequate experience in similar nature of work including Sewerage, Water supply and General Civil Engineering & Maintenance. The firms should be eligible to handle the work and should have valid registration with PEC in Category **C-5 & above** with relevant fields of specialization, having valid income tax registration with FBR.

1. Interested Firms / Bidders may purchase the Bidding Documents up to **13-01-2023** during working hours from office of the undersigned upon non-refundable pay order amounting **Rs.3000/-** in favour of **“Federal Government Employees Housing Foundation”**. The same can also be download from FGEHA' website.
2. Bidders will be technically **Post-Qualified** on the basis of information provided in the Technical Bids as per criteria prescribed in the Bidding Documents.
3. A pre-bid meeting will be held on **12-01-2023** at **01:00 PM** in the office of the undersigned.
4. Single Stage Two Envelope (SSTE) Bidding Procedure will be adopted. Envelopes containing technical information of bids must be clearly marked as **“Technical Bid”**, and the envelopes containing the Bid Price must be clearly marked as **“Financial / Price Bid.”**
5. The envelopes of Financial / Price Bids must be accompanied with a minimum **3%** of bid amount as **Bid Security** in the form of **Deposit at Call** in favour of **“Federal Government Employees Housing Foundation”** with an undertaking in Technical Bid that Bid Security is sealed with the Financial / Price Bid.
6. Partial, incomplete and conditional bids will not be considered.
7. Technical and Financial / Price Bids are to be submitted at the address mentioned below by **17-01-2023** at **12:00 PM**. The envelopes containing Technical Bid shall be opened on the same date at **12:30 PM** in the office of the undersigned in the presence of bidders or their authorized representatives.
8. The envelopes of Financial / Price Bids of the bidders who fail to post-qualify shall be returned unopened.
9. The decision of FGEHA shall be final and binding on all the bidders. FGEHA shall not entertain any claim whatsoever for cost(s) incurred by the bidders for preparation and submission of the bids.
10. The envelopes of Financial Bids of only responsive and technically qualified firms will be opened in the presence of bidders or their authorized representatives at date and time to be determined and communicated later.
11. All the applicable Federal / Provincial Taxes must be considered while preparing the financial proposals and are required to be built in the quoted rates. The bidders providing fake, false, and forged information shall be liable to disqualification and / or blacklisting.
